



Thank you for taking the time to write a personal letter to our elected officials. You can include it as an attachment or in the body of an email – whichever is easier for you. Letters and emails are critical to letting officials know how their constituents feel about the installation of these towers.

Your comments should be very personal: explaining that you live in or near a Historic District, that the towers are unsightly and will upset your quality of life. Below is suggested sample language you can use:

“If the tower (or facility) is built, every time I look out my kitchen window while washing the dishes, this thing will be staring me in the face.”

“Anytime I look out my bedroom window or any window from any room on the north side of my home, this thing will dominate my view.”

“Anytime my wife and I entertain family or friends on our deck in our backyard, this thing will be looming over us.”

“This thing will dominate the skyline and destroy the sunset views we have enjoyed since we purchased our home, and which was the reason we chose our home in the first place.”

“If installed in front of my house, as proposed, this facility will be the very first thing our friends and relatives will see when they pull up to our house. It will entirely destroy the aesthetics and curb appeal of our home, despite the fact that we have worked so hard and spent substantial amounts of money to make our home visually appealing.”
